One firefighter is currently taking a week long NFPA 1002 Pump Operators course at the Sault Fire Regional Training Center. One of our captains is also attending as an instructor.

Our intent is to outfit the saw for roof operations which would include adding a carbide chain, heavier chainsaw bar, depth guage and a high capacity battery pack. 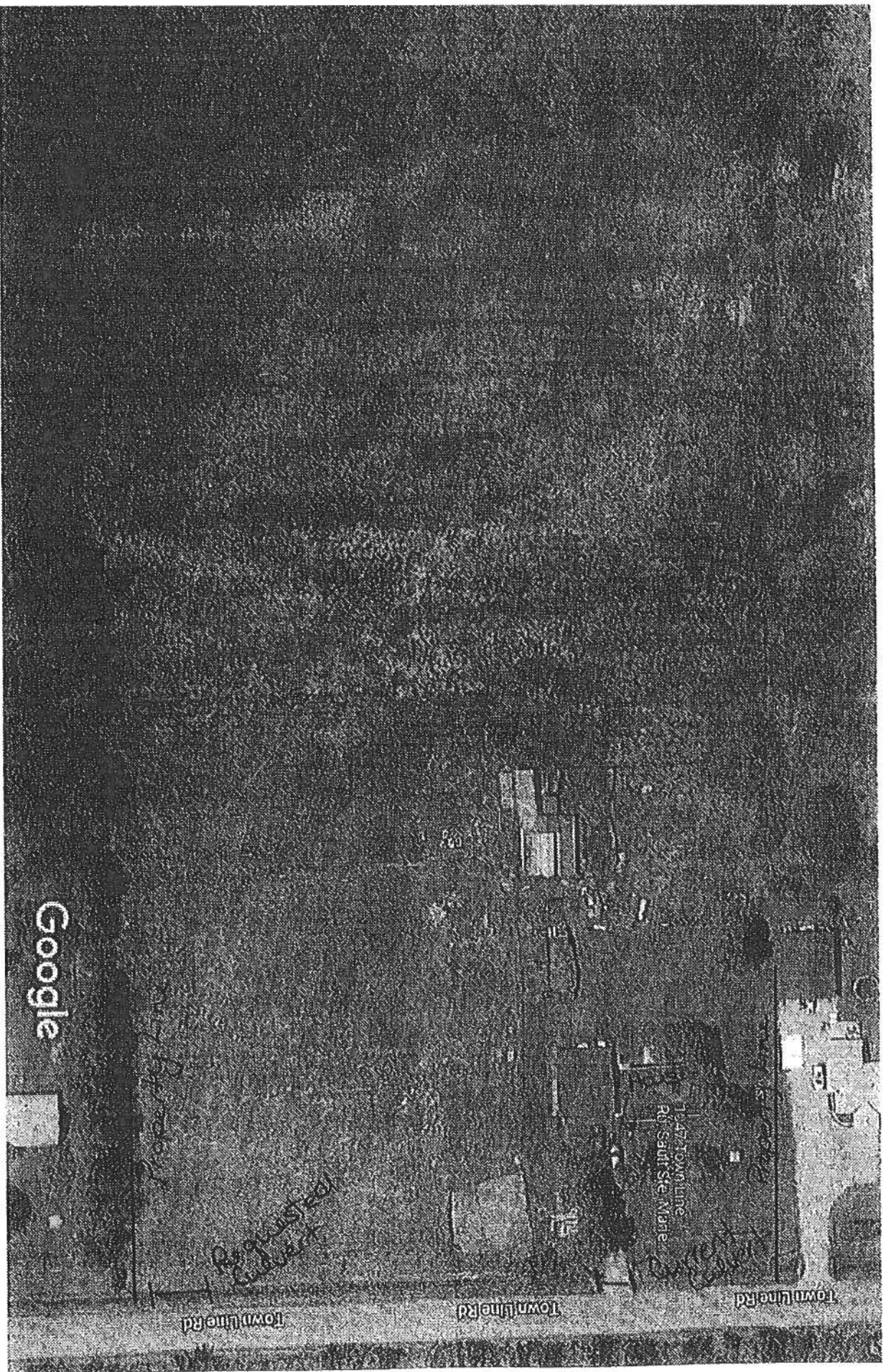

Walls road has too many to keep up. I recommend putting out a tender for later this summer or early fall to prep for surface treating or asphalt next season. **This would be part of the NORDS Grant as stated in the May roads report.**

The tender for surface treating this year was awarded to Averys at a cost of \$222,282.91 which is a little more than the \$200,000 budgeted. The difference will need to be found in the budget.

Replacing the township pickup (2009 Chevy) should be done soon to have for the 2023 season.

Memo to Employers

In our March memo regarding the non-full-time (NFT) Plan change, we let you know that, starting in January 2023, OMERS would take on the role of offering enrolment in the OMERS Plan to all NFT employees hired on or after January 1, 2023 who are subject to voluntary enrolment.

We have since received feedback that some of you have established processes for offering enrolment and would like to continue offering enrolment yourselves. To that end, OMERS is providing employers with the option to send the enrolment offer to their NFT employees, who are subject to voluntary enrolment, starting in January 2023.

With either option, you must provide OMERS with detailed information about your NFT employees within 30 days of hire. In circumstances where you send the offer to enrol directly, OMERS will also send a separate communication to voluntary NFT employees that will help them make an informed decision on whether to join the Plan.

We're asking all employers to choose an option by **June 30, 2022**, by completing this [short survey](#).

Important: *If we do not receive your response by June 30, your organization will be defaulted to Option B where OMERS will send the enrolment package to your NFT employees.*

To assist you in making your selection, here are some important points to consider with each option.

Option A: Send the enrolment package to your NFT employees directly

With this option, your responsibility as an employer is to ensure all NFT employees receive an enrolment package and to keep a record of all offers you make. Similar to today, if at a later date an employee claims not to have received the offer, you must have sufficient proof to show otherwise. If proof is not obtained, an omission period may occur.

Also, you must send OMERS the following data for all NFT employees who were offered enrolment:

- First Name, Last Name
- Last 3 Digits of SIN
- Date of Birth
- Date of Hire
- Email Address
- Language Preference
- Employee ID
- Employment Type (i.e. casual, seasonal, temporary/contract, student, part-time, other)
- Union Affiliation
- Salary or Pay

As noted above, this data would need to be sent within 30 days of the hire date for OMERS to provide NFT employees with the information they need to make an informed decision about joining the Plan in a timely manner.

Option B: Have OMERS send the enrolment package to your NFT employees

With this option, on and after January 1, 2023, your responsibility as an employer is to ensure OMERS receives accurate NFT employee information within 30 days of the employee's hire date to allow OMERS sufficient time to offer enrolment in the Plan. If you do not send the information or send it later than 30 days from the employee's hire date, an omission period may occur.

To enable OMERS to offer enrolment, you must send OMERS the following data for your NFT employees who are eligible to be enrolled in the Plan:

- First Name, Last Name
- Last 3 Digits of SIN
- Date of Birth

- Date of Hire
- Mailing Address
- Email Address
- Phone Number(s)
- Language Preference
- Employee ID
- Employment Type (i.e. casual, seasonal, temporary/contract, student, part-time, other)
- Union Affiliation
- Salary or Pay

Plus: Data for additional NFT employees eligible to enrol on January 1, 2023

We also request that employers provide to OMERS the following data for (1) all existing NFT employees by October 31, 2022 and (2) NFT employees **hired between November 1, 2022 and December 31, 2022** by December 31, 2022:

- First Name, Last Name
- Last 3 Digits of SIN
- Date of Birth
- Date of Hire
- Language Preference
- Employee ID
- Employment Type (i.e. casual, seasonal, temporary/contract, student, part-time, other)
- Union Affiliation
- Salary or Pay

More information on the frequency of data submission to OMERS will be shared with employers in future communications, including NFT emails, education sessions and webinars.

STAFF REPORT JUNE 14, 2022

KITCHEN UPDATE: REQUESTED BY MAYOR KEN LAMMING

The range hoods we were waiting for never came in, but last week Topline chose to install two residential units in their place to get the job finished. The second stove was delivered on June 10th. Staff will have the cleaner come in for a thorough clean and then the kitchen will be in complete order for use.

The mayor has intervened to inform staff the Women's Institute would like a resolution made to assign kitchen storage for their dishes and to install locks to the cabinetry for security. This was not in the original plan and will need additional funds to install. This is a staff matter and not a decision for council.

In relation to the range hoods, it came to staff's attention someone who was not office staff communicated with Topline Electric to inform them that the holdup in finishing the kitchen was preventing the rental of the hall. After receiving this information, Topline's owner instructed his staff to find a comparable alternative to install. This decision was known to staff after the units were already purchased and being installed. We are waiting on confirmation that the residential units are identically comparable to the original industrial ones. We have requested the new units to be replaced with the original order if that comparison is not ideal.

Please Note: All requests to staff must be made through resolution of council and not by individual councillors or the mayor. This has not been followed in the past or with this latest example of the kitchen renovation. It is imperative that the rules are followed to keep staff/council relations in good standing. Thank you for your co-operation.

Response to Algoma District Municipal Association From Michael Mantha – Algoma-Manitoulin NDP

Thank you for this opportunity to respond to the ADMA's concerns. Each of the three items that the association has identified are critical issues that the next government must tackle for Northern Ontarians to have any chance of having an even playing field to move forward and prosper.

1. Can you tell us what your government plans to address the housing crisis in rural and remote communities?

New Democrats know that the North has been an afterthought by government for decades. Sometimes we even feel totally forgotten. Other times governments neglected to consider the unique circumstances that exist for Northern people, communities and businesses. That is why the NDP released a platform that explicitly addresses and offers solutions for Northern issues and realities.

The NDP believes that housing is not a privilege but is instead a human right. People should be able to access a safe, affordable home that is ready for them when needed at various stages of life. As well, every working family should be able to have a place they are proud to call home in the community where they live and work.

Ontario finds itself on the brink of a humanitarian homelessness crisis. Unfortunately, for decades, Conservative and Liberal governments have made the housing crisis worse and worse. The Liberals had 15 years to help – but they chose not to. Northern Ontarians deserve better.

Starting in 2022, if elected, an NDP government will:

- Make renting more affordable, and give renters more security
- Make it easier to buy a home, and strengthen homebuyers' protections
- Take on greedy billionaires, speculators, flippers and bad developers to cool the market
- Provide support for Indigenous employment and an Indigenous housing strategy
- Tackle the housing shortage that exists in some areas of Northern Ontario
- End homelessness and give more people safe and stable housing options

The cost of a down payment is an insurmountable barrier to homeownership for many Ontario families. As a result, some couples make the heartbreaking decision to put off growing their family because they just can't afford a suitable place. Some are forced to live in cramped conditions, unable to accommodate their growing or multi-generational families. And others are priced out of the neighbourhoods they love altogether – forced to leave the familiar places where they grew up, near their families and communities.

An NDP government will help first-time homebuyers with their down payment. One means of doing this is with a shared equity loan of up to 10 percent of a home's value. Repayment of the loan won't be necessary until the homeowner sells or moves out, and homeowners will have the option of buying back the government's share at any time.

Northern Ontario needs to increase the supply of homes that people can afford. One way this can be done is to encourage more basement apartments, laneway houses and granny flats. A paradox of the housing crisis is that while many people struggle to find an affordable place to live, many others have more living space than they need or want — and could use extra monthly income. That's why an Ontario NDP government will create a new *Residents' Rights Act* so homeowners can easily and inexpensively convert an unused garage, basement or floor into an affordable rental home.

Living in the North comes with added inescapable costs, including travelling long distances to access goods and services not readily available locally. In addition, due to colder temperatures, inflated energy prices, and older homes with inefficient heating systems and insufficient insulation, we also face higher energy costs. To help ease these issues, the NDP has prepared our **Green New Democratic Deal**. Under such a program, we'll introduce new, environmentally progressive building standards and, just as importantly, support families in renovating their homes to make them greener, more energy-efficient and reduce their carbon footprint and energy bills.

Also stated in the ADMA preamble is the fact that in some Northern communities, housing stock hasn't kept up to demand. This hinders population growth and leaves families with too few options. And it makes waiting lists far too long for options like affordable, supportive and transitional housing.

The NDP will tackle the shortage of housing options in Northern Ontario and make living in your own home more affordable.

We will build 30,000 new homes with supports, and 69,000 affordable housing units. But, unlike previous governments, we'll make sure the North gets its fair share by committing to 6,000 new affordable housing units in Northern Ontario and 3,600 units of supportive housing.

Recognizing the unique housing challenges in Northern Ontario and taking a multi-faceted approach to fixing them, New Democrats can end the waits, end the searches and get people into quality, safe homes they can afford.

2. Please describe to us how your government would address access to high-speed internet and mobile coverage in the remote rural areas of Ontario.

As the ADMA is well aware, prior to the pandemic, many Northern communities were doing everything within their power to gain access to affordable, up-to-date high-speed broadband. New Democrats consistently pressed the Ford Government to act and make sure that people have guaranteed access to this essential service wherever they live in our province. This, too, has been a high priority for the NDP. We know that a \$1 billion investment in infrastructure is needed to ensure that all rural and Northern Ontario communities can access quality internet services.

To quote the *Northern Policy Institute*:

“The Canadian Radio-television and Telecommunications Commission (CRTC) states a target bandwidth of 50 Mbps (megabits per second) download speeds and 10 Mbps upload speeds to smoothly participate in the digital economy (CRTC 2019). In Northern Ontario, there is a significant lack of access to this target speed. In fact, 15.5 percent of the population still have bandwidth speeds below the 50/10 Mbps target through any delivery method. That is 120,932 residents out of 780,140 Northerners. For these households, their main options are DSL, cable modems, and/or fixed wireless.”

We have been very disappointed to hear time and time again that the current Conservative Government, just as the previous Liberal Government, would make a significant investment in broadband but see nothing actually happen.

Here we are halfway through 2022, and still, most of the North is without affordable high-speed internet. We frequently read government announcements that rural communities in Southern Ontario are getting approval for expanding highspeed broadband, but nothing for Northern communities. When will it be our turn? The uneven playing field leaves Northern residents at a distinct disadvantage.

We know Northern Ontarians are tired of being left behind. That’s why the NDP will make affordable high-speed internet available province-wide, **including in Northern Ontario**, by or before 2025. We will target a broadband speed standard of 1 Gig symmetrical using future-proofed fibre technology and ensure local small and medium-sized internet service providers can participate — not just large telecom monopolies. And unlike Doug Ford’s Conservatives, we will ensure investment actually flows.

3. Please describe issues that you’ve seen in healthcare for the people of Algoma-Manitoulin and tell us how your government would approach healthcare. Include specific key aspects and what needs to be done to ensure they work properly.

Among the highest priorities for any elected government is meeting the healthcare needs of the citizens. New Democrats subscribe to this policy, as do I.

Since I was first elected, I have eagerly accepted and even requested formal and informal meetings with hospital and family health team administrators, doctors and nursing associations, and NOSM. As a result, I am proud to say that I am well engaged with the various stakeholders and aspects of overall healthcare.

Successive Liberal and Conservative governments have broken Ontario’s healthcare system. They did not keep up the necessary investment and essential “maintenance” of the system. Instead, they made deep cuts to funding, and fired thousands of healthcare workers, including nurses. But the NDP knows how to fix healthcare and we are proud to share our plan. And because the NDP understands the unique circumstances that

affect healthcare in the North, we have included it as part of our special Northern platform.

The first, and perhaps longest-running, challenge that I have been working on for the North is the desperate shortage of healthcare workers, with the shortage of doctors leading the list. Hardly a week goes by that my office doesn't receive calls from constituents who desperately need to get onto a roster but can't because family physicians' patient load is already maxed out. As a result, they are forced to continue going to hospital emergency rooms just to get prescriptions that they need on a regular basis. And they don't have anyone actually monitoring their overall health to make sure any issues are caught early enough to treat successfully. And the same story can be applied to accessing mental health care.

According to Dr. Adam Kassam, president of the Ontario Medical Association, in the North, overall, 300 doctors are needed: 100 family doctors, at least 40 more in urban settings, and 160 specialists. Kassam wrote, "The Northern disparities in health care have existed for many years, but COVID-19 has made these gaps more visible and the need for solutions more urgent."

I should also point out that I have spoken to and met with several doctors in the riding who have been trying to plan to retire from their practice in small-town rural communities. They have worked diligently for several years, independently and with the assistance of family health team administrators, to attract new doctors to come in and take over their practice. After meeting with them, I understand their situation well and am committed to doing all I can to help them and future doctors achieve their retirement goals and still meet the needs of the community.

These many problems need to be acted upon now and resolved permanently.

The NDP plan for Northern healthcare is to immediately hire and recruit 300 doctors in Northern Ontario, including 100 specialists and 40 mental health practitioners. In addition, we will work with the OMA and Northern communities to enhance incentives and support for physicians and healthcare workers to practise in Northern Ontario and other chronically underserved communities. We will also work with the College of Physicians and Surgeons of Ontario to expedite the process for international medical graduates to obtain their license to work in Northern Ontario.

As an example, the *North Shore Health Network* has been forced to face the potential closure of its emergency department on several occasions because of a shortage of doctors. This puts the health and very lives of thousands of people at risk. This is entirely unacceptable anywhere in this province. I have participated in several meetings with administrators and stakeholders to help find means to resolve this problem in both the short and long term. I have also had multiple face-to-face meetings with the Minister of Health to personally appeal for immediate attention and action to resolve this matter.

It is important to note that my colleagues and I understand that, while there is a need to resolve this problem now in the short term, we also need to be looking forward to ensuring this situation is fixed in the long term. That is why the NDP plan includes:

- Training more doctors and health professionals to work in the North by expanding the number of seats and training opportunities at NOSM University,
- Funding travelling doctors to bring a resident with them when they go to a Northern Ontario community to practice,
- Increasing student aid and introducing a special scholarship program for students from Northern Ontario who want to become health care practitioners.
- Recruiting nurses to work in the North. We will create rural nursing mentorships which will allow recent graduates to work with experienced nursing professionals in Northern communities.

The final issue that my office receives many calls and appeals for assistance is regarding the slow response time in processing Northern Health Travel Grants (NHTG). The Liberal and Conservative highway medicine policy is not working for Northerners. This is especially challenging for patients who require frequent travel to larger centres for consultation and treatment. While the Ministry of Health does eventually payout the grants applied for, people do not receive payment in a timely manner. Many complain that they have to drain their bank accounts or max out credit cards because sometimes it takes weeks or even months to receive NHTGs.

It is important to note also that complaints of such delays appeared long before Covid-19 reared its ugly head. Northern Ontarians have the right to equal access to medical treatment and services no matter where they live. This is why my Northern NDP colleagues and I are committed to improving the *NHTG* with a service guarantee, ensuring that Northern residents will not have to wait longer than 14 days when they incur travel expenses to get the care they need.

As well, Ontarians have been struggling with affordability issues, including food and accommodation including when they have to travel for medical appointments. And gas prices are rocketing out of control. That's why in addition to implementing a service guarantee the NDP will review grant levels to better reflect the reimbursement levels for travel and accommodation.

Zero Emission Vehicle Infrastructure Program

The Government of Canada has set a mandatory target for all new light-duty cars and passenger trucks to be zero-emission by 2035, accelerating Canada's previous goal of 100% sales by 2040. While the Government of Canada has already invested over \$1 billion to support increased zero-emission vehicle adoption, it will pursue a combination of investments and regulations to help Canadians and industry in this transition.

The **Zero Emission Vehicle Infrastructure Program (ZEVIP)** is a \$680 million initiative ending in 2027 and its objective is to address the lack of charging stations in Canada; one of the key barriers to ZEV adoption, by increasing the availability of localized charging opportunities where Canadians live, work, and play.

This funding will be delivered through cost-sharing contribution agreements for eligible projects that will help meet the growing charging demand.

NOTICE

The Request for Proposals (RFP) focusing on public places, on-street, multi-unit residential buildings, workplaces and vehicle fleets is now open until **August 11, 2022 (23:59 Eastern Daylight Time)**.

The program targets multiple infrastructure streams as described below.

Public Places

The program will support electric vehicle charging infrastructure deployment in parking areas intended for public use. Parking areas can be privately or publicly owned and operated.

Examples of public places include, but are not limited to: service stations; retail; restaurants; arenas; libraries; medical offices; park and ride; etc.

On-Street

The program will support electric vehicle charging infrastructure deployment on-street. On-street charging is considered charging infrastructure for public use and is managed by local governments.

Workplaces

The program will support zero-emission infrastructure deployment at workplaces. A workplace is defined as a location where employees perform duties related to a job. For the purpose of the program, the charging infrastructure must be primarily used by the employees.

Charging infrastructure installations at a private residence even if a business is registered at the same address, are not included in this category.

Commercial and Public Fleets (on-road)

Commercial and public fleets are composed of on-road vehicles and are managed by common ownership. These fleets are used in support of organizational or business operations and activities.

On-road commercial and public fleets include but are not limited to: light, medium or heavy-duty vehicles, taxies, last-mile delivery vehicles, or **municipal utility vehicles**.

How much can you receive?

The maximum funding per type of infrastructure is as follows:

Type of Infrastructure	Output	Maximum Funding
Level 2 (208 / 240 V) connector	3.3kW to 19.2kW	Up to 50% of total project costs, to a maximum of \$5,000 per connector*
Fast charger	20kW to 49kW	Up to 50% of total project costs, to a maximum of \$15,000 per charger
Fast charger	50kW to 99Kw	Up to 50% of total project costs, to a maximum of \$50,000 per charger
Fast charger	100 kW to 199 kW	Up to 50% of total project costs, to a maximum of \$75,000 per charger
Fast charger	200 kW and above	Up to 50% of total project costs, to a maximum of \$100,000 per charger

WHEREAS there is a desperate need for expanded residency programs at the Northern Ontario School of Medicine University NOW for primary care and emergency physicians, as well as paediatricians, anaesthesiologists, psychiatrists, OB/GYN and other specialties, without waiting for Royal College approval which takes roughly 18 months;

NOW THEREFORE BE IT RESOLVED THAT the Premier of Ontario and the Minister of Health respond to the requests from the NOSM University and Northern Ontario communities to transform Human Health Resource Planning immediately to relieve the health care crisis occurring now, with no doctors, a severe nursing shortage, limited powers of nurse practitioners and lack of access to other health disciplines; and

THAT the Province accelerate the approval process so that expanded medical student intake can commence in the fall of 2022; and

THAT this resolution be circulated to all Northern Ontario municipalities, ADMA, the Premier of Ontario, the Ontario Minister of Health, Northern Ontario MPP's, and Dr. Sarita Verma, President, Northern Ontario School of Medicine University.

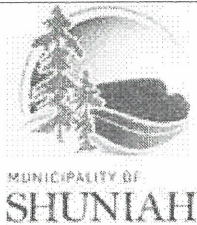



What Is a Skatepark?

Modern skateparks are as diverse as the urban and natural environments they draw inspiration from. They feature deep undulating forms and have geometric and blocky structures. Skateparks are reflections in concrete of structures and shapes found around the community; a picnic table, a swimming pool, a handrail, stairs. Skateparks interpret and improve upon those structures that have been attracting athletes, adventure riders and thrill seekers for decades.

A skatepark creates a community gathering space that celebrates and supports outdoor recreation for all ages. A thoughtfully designed site has the great potential to grow with the community and add value for a great many years.

The “what is a skatepark” question can also be answered and determined by considering three main components:

- 1). Size. A skateparks’ size determines how many structural attractions it can accommodate. A large park can allow for more cool stuff and lets’s more riders safely and comfortably use it at once. An undersized skatepark does just the opposite; few people can use it at once and the overall space runs the risk of being under used.
- 2). Material. There are a multitude of options for materials! Cast-in place concrete, Shotcrete, precast, steel, prefab polymer etc. Obviously, suitable materials are chosen based on location, weather considerations, longevity, maintenance etc. Often, the materials used can dictate the enjoyability of the riding surface. Specific materials are chosen with both safety and usability in mind.
- 3). Design. This is the fun part! Choosing gnarly features to create a fantastic experience for all riders! Half-pipes, handrails, ledges, pyramids, bowls, banked ramps, verts, kickers, funbox, stairs... So many options! Any number of features can be combined to create a wicked riding experience for skaters, kids on scooters and the bmx crowd too!

A well planned, thoughtfully designed park can successfully combine features to satisfy the needs of all “wheeled riders”. With a bit of foresight and creative ingenuity, a multi-purpose facility is a welcome addition to an active community.

How Can This Benefit Our Community As a Whole?

A properly designed skate and bike facility can be a catalyst for healthy community life in which all ages can socialize, have fun, develop new skills, make new friends, hang out and build community.

It creates a safe and clean outdoor activity facility for youth, a meeting zone for parents, grand- parents and community members. Parents can chat on a bench while their younger children skate or ride. Older kids get an opportunity to meet and socialize with other kids in the community that they might not have had the opportunity to do before. Public skateparks and pumptracks tend to foster a mutual respect and tolerance among riders; which means all riders, regardless of age or skill level, have the time to get a few runs in before the next group drops in. Riders look out for one another and jump in to lend a hand if someone needs help with a repair, needs guidance with a particular trick, or just needs a pep talk to keep going and keep trying!

A skatepark in Prince Twp. will create a safe, centralized hang-out spot for the youth of Prince Twp. It will also give them a safe place to skate and ride by keeping them off our increasingly busy and potentially dangerous township roads.

Further community enhancements to the site could include;

- Permanent picnic tables (metal commercial tables set in-place in concrete)
- A coat rack/storage area (to hang up or safely set aside back-packs, jackets etc)
- Drinking water fountain
- Bear proof trash cans and recycling bins
- Park benches
- Electrical outlet
- Exterior lighting
- Onsite permanent tool station (basic tools; allen keys, adjustable wrench, air pump...)

Why this location?

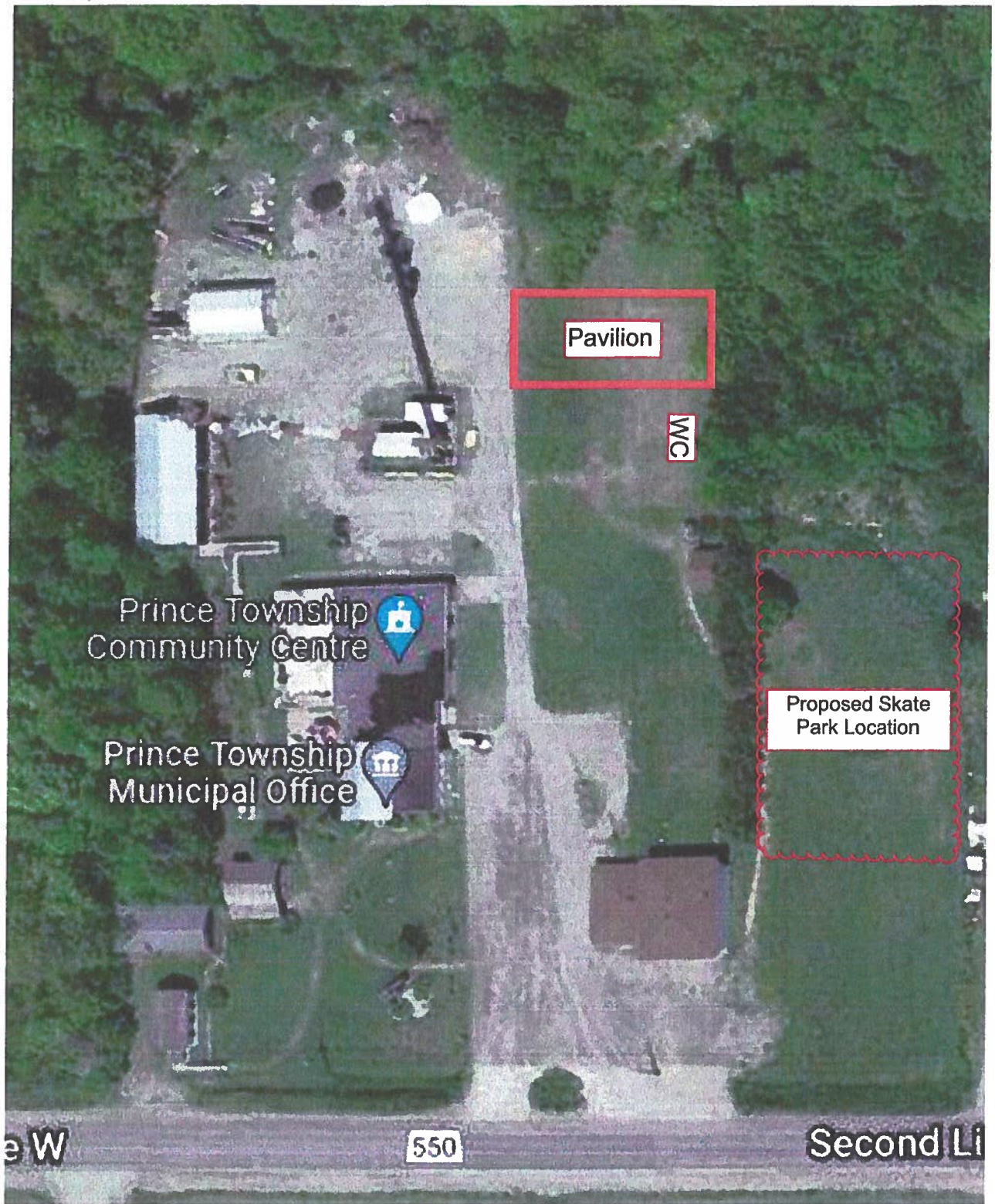
- Central location making it easy for all community members to access

Construction

Wait a minute, is this going to be difficult and complicated to plan and construct?

Nope.

There are several companies in Canada that specifically build skateparks (and other “wheeled” outdoor sports recreation facilities like pumptracks). Many companies offer multiple levels of service and involvement; From a fully developed and constructed turn-key park, to engineered drawing and blueprint packages and design services to be utilized at a grassroots level.

Just like all major construction projects, comprehensive planning and a solid foundation are critical to the overall success of the project. Industry professionals will offer years of reputable, reliable, tried and true expertise.

I’ve personally reached out to a few key players within the industry.

At the time of the submission of this proposal, I’ve initiated a dialogue with one of the largest and most recognized full service companies, Newline Skateparks. They have several offices across Canada and are an absolute wealth of professional information. I look forward to continuing a dialogue with them.

Included in this proposal, is some preliminary information about Newline Skateparks; services they offer, their philosophies and company values.(Included as an example of how hiring a professional industry leader can help us realize the goal of building a modern skate facility in our growing community).

Funding

Now we get down to the nitty gritty. The moola. The cold hard cash. The bill.

Because there are so many variables to a project of this nature, there isn't an "industry recognized price per sq ft" cost structure.

The specific site chosen, design considerations, over-all community enhancements and integration, construction timelines, features added; all of these factors, and more, will contribute to the final cost. As the proposed future site of the Prince Twp skate facility is mainly flat, and devoid of trees, the cost of site prep for initial groundworks will be minimal. The site also has easy access for equipment during the construction phase.

In the included Newline Skateparks brochure, there are many completed project overviews that include the size of the finished facility as well as a realized cost for the project. Everything from a small \$275,000 facility in Peachland BC to a huge \$2.5million facility in Frisco TX! And of course, many excellent parks and plazas of every size and cost in between. The municipal team in charge of building a skatepark facility really is spoiled for choice!

As mentioned previously, there is so much potential for artistic vision in design! There is a huge list of potential rideable features and challenging aspects to be added to a skatepark! The obvious first consideration would be accessibility and usability for the greatest number of end users. Features for the new riders as well as the seasoned riders and skaters. But as many of the features included in popular modern parks, intrinsically include multi purpose structures, the accessibility for all skill levels naturally flows.

There are so many avenues of funding to help realize the main capital goal:

- Municipal recreation budgets and community enhancement funds
- Private fundraising and donations
- Corporate sponsorships
- Government grants
- Local business donations

In Conclusion

This proposal package included a lot of information. My goal was to include as much relevant info as possible to emphasize the need for this type of facility in our community, as well as reasonable steps to take to make it happen. Have I ever built a skatepark before? No. Have I ever submitted a formal proposal of construction for a community feature before? Also no. Do you have any questions after reading through the proposal package? Probably.

As you can see from the amount of signatures collected on the petition, there is a lot of interest in this project for our community! Kids want it because they just want to ride and skate and get outside and get active doing something super fun. Parents want it because it will create a close and safe community space for our kids and neighbours. Grandparents and community elders are interested because they recognize that there is possibly the greatest number of kids living in our immediate area as ever before!

Also, a project of this nature builds on the momentum that has been underway to make the Prince Twp community one of inclusion and physical activity. A forward thinking community that considers the well being of all citizens while maintaining the "small town feel". The Events Pavilion has been an absolutely amazing feature, and long lasting legacy for our community. I'm hoping to springboard from that "build into the future" momentum and add a modern skatepark to the list of great features in our area!

So in conclusion, I look forward to answering any questions I can about this proposed project as well as playing any part necessary to facilitate the final design and construction decisions.

Covering a total area of over 44,000 square feet, the Plaza at the Forks consists of a meticulously detailed skateable sculpture plaza and expansive modern bowl complex tied seamlessly into the heart of downtown Winnipeg's urban fabric. The facility is the first of its kind within the world and has quickly become one of Winnipeg's most celebrated public places and a destination for skateboarders and other urban explorers from around the globe.

The concept for the Plaza was unique from the onset. The Forks, aptly named due to its position marking the amalgamation of Assiniboine and Red rivers, serves as one of Winnipeg's preeminent meeting places. The area is steeped in over 6000 years of cultural and historical significance and is visited by over 4 million people each year for a range of attractions and activities. Accordingly, the riverside setting is highly programmed with stringent development guidelines and a commitment to utmost site sensitivity. Our team's challenge was to preserve the essence of this beloved public space while introducing a thoroughly modern world class youth/skatepark.

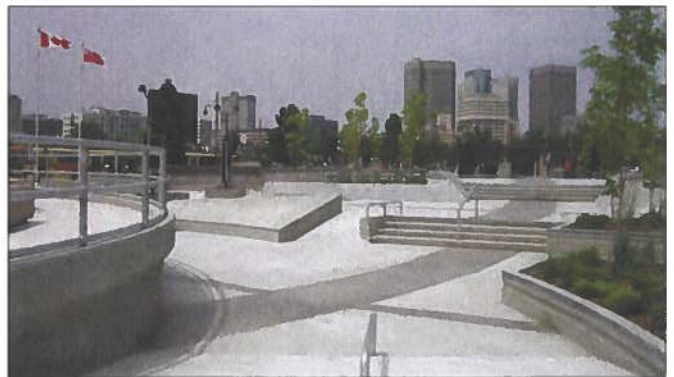

The result is an urban landscape like no other. Far from the typical skatepark, the Plaza at the Forks is better described as a premier urban park/plaza and gathering place that is 'perfect for skateboarding'. On any given day, one may see up to hundreds of visitors skateboarding, inline skating, biking, viewing art, strolling through, or simply sitting by to watch and socialize. It has truly become a place for all ages, backgrounds, and interests to enjoy.

Central Plaza: Inspired by prized skate spots around the world and the rich history and culture of the Forks district, the main plaza area is made up of an endless combination of stair sets, banks, rails and ledges set within a host of custom sculptures and other art pieces - the majority of which may be ridden by skateboard, BMX or inline skates. Along with input from heritage and culture experts, our team undertook extensive consultation with leaders of the local skateboarding and art community to devise a final layout and detailing that would be optimal not only in skate function but also true to the culture and feel of the Forks and City of Winnipeg. Particular highlights include:

- 'Spirit Fish', a skateable sculpture designed to represent the nearby rivers and the mystical 6000 year old catfish that used to inhabit their waters - painted by local artist Pat Lazo
- 'Magic Carpet', a super elevated and perfectly skateable concrete ribbon track referencing the railway lines that met at Winnipeg's main terminal within the Forks until 1923
- Numerous granite capped benches, ledges and blocks
- Wire cut stone and acid etched concrete accents
- Original Forks brick inlaid on pedestrian walkways



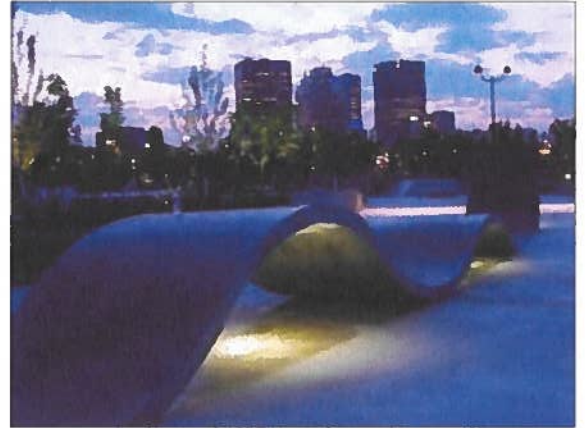

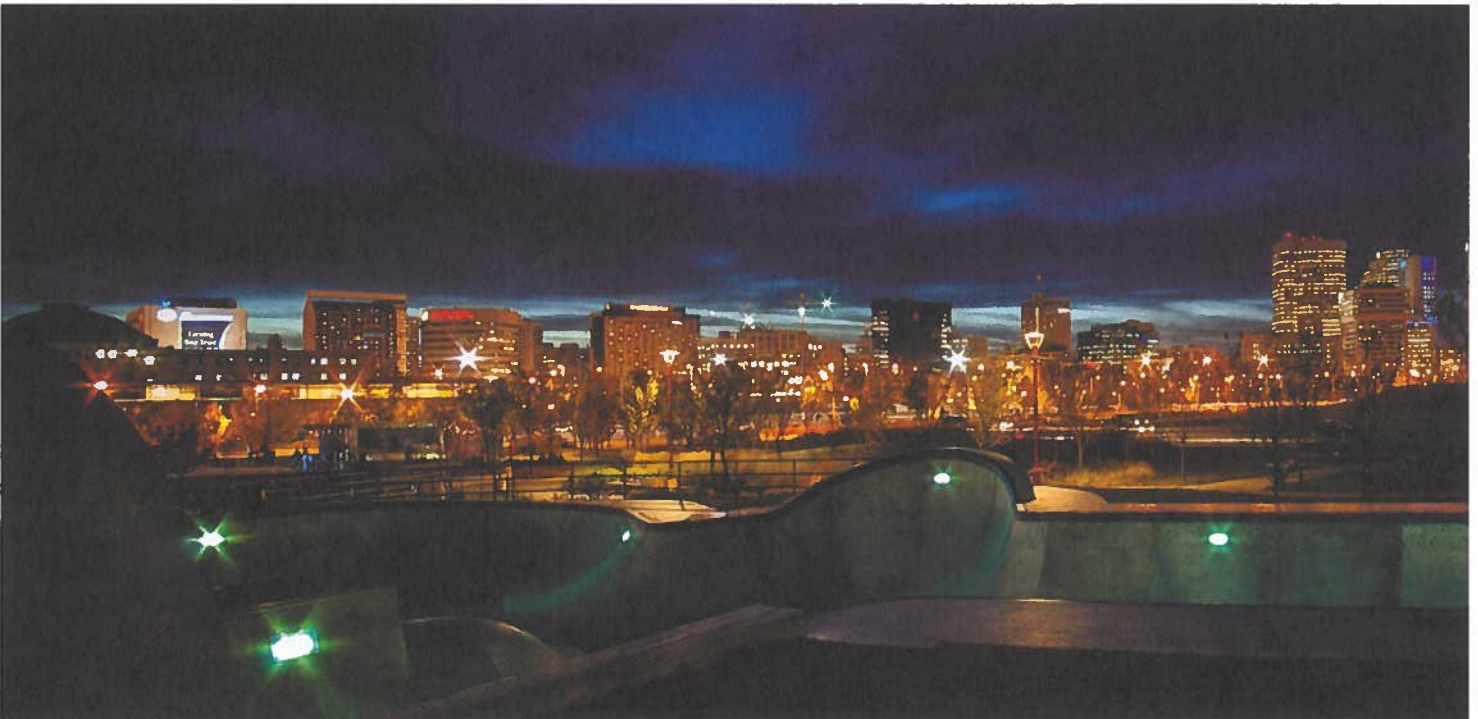
Bowl Complex: Separate and adjacent to the Central Plaza, lies an 8,500 sqft. bowl unit combining traditional pool and modern coping lines. Walls begin at 5 feet and progress through a series of hips, elevators, extensions, and a pump bump to a massive 17 foot cradle and 13 foot over-vert pocket. Ridden by beginners through to the likes of Tony Hawk (who recently touted the park as 'amazing'), the bowl can often become the center of activity with hundreds of spectators in the surrounding informal viewing areas.

Our team finished the park off with unique lighting, a network of 'safe' pedestrian walkways and viewing areas, and consultation on the creation of an 'Ambassadors' program designed to educate visitors on skateboarding etiquette and ensure an enjoyable experience be had by all.

The entire project is built on state of the art construction and engineering designed to withstand the difficult ground conditions and dramatic temperature fluctuations characteristic of the region. Proven cold weather skatepark construction techniques developed by New Line Skateparks were matched with innovative void forming and reinforcement technology implemented by PCL and local engineers. Over 200 precast piles, highly specialized concrete mix designs, and an expansive grade beam system will ensure maximum surface integrity over many decades to come.

Built in 2004 as a temporary youth facility for the Vancouver Parks Board, the Vancouver Skate Plaza successfully uses an underutilized scrap of industrial land under the Georgia Street viaduct and transforms it into an internationally recognized street-style skateboarding plaza. The design was developed in close partnership with the Vancouver Skate Coalition, the Vancouver Police Service, and surrounding community members through a series of interactive workshops and a custom online forum set up for ongoing stakeholder feedback. Key emphasis was placed on creating true 'urban form', maximizing available budget through creative use of existing site infrastructure and value engineering, identifying appropriate skateable and non skateable access routes both to and around the site, and the implementation of sound CPTED principals. Since its completion, the park has served as the basis for case studies across North America for the development of successful youths parks in areas undergoing urban renewal. In 2005, the Canadian Society of Landscape Architects acknowledged the project's success in the community with a Regional Honour Award.

Motion 10.3 - Councillor Thompson; Re: Mandatory Firefighter Certification

Please be advised that this matter was considered by Council at its meeting held on May 24, 2022, and in this regard, Council adopted the following resolution:

Whereas municipal governments provide essential services to the residents and businesses in their communities; and

Whereas the introduction of new provincial policies and programs can have an impact on municipalities; and

Whereas municipal governments are generally supportive of efforts to modernize and enhance the volunteer and full-time fire services that serve Ontario communities; and

Whereas the Association of Municipalities of Ontario (AMO) believes in principle that fire certification is a step in the right direction, it has not endorsed the draft regulations regarding firefighter certification presented by the Province; and

Whereas municipalities and AMO are concerned the thirty-day consultation period was insufficient to fully understand the effects such regulations will have on municipal governments and their fire services; and

Whereas fire chiefs have advised that the Ontario firefighter certification process will create additional training and new costs pressures on fire services; and

Whereas the Ontario government has not provided any indication they will offer some form of financial support to deliver this service; and

Whereas AMO, on behalf of municipal governments, in a letter to Solicitor General Jones dated February 25, 2022, made numerous comments and requests to address the shortcomings in the draft regulations;

- 1. Now Therefore Be It Hereby Resolved That the Town of Aurora does hereby support AMO's recommendations; and**
- 2. Be It Further Resolved That the Town of Aurora does hereby call on the Solicitor General of Ontario to work with AMO, municipal governments and fire chiefs across Ontario to address the concerns raised so that municipalities can continue to offer high quality services to their communities; and**
- 3. Be It Further Resolved That a copy of this Motion be sent to the Association of Municipalities of Ontario (AMO), the Ontario Small Urban Municipalities (OSUM), and all Ontario municipalities for their consideration.**

Motion 10.1 - Councillor Humfryes; Re: Private Member's Bill C-233 "Keira's Law"

Please be advised that this matter was considered by Council at its meeting held on May 24, 2022, and in this regard, Council adopted the following resolution:

Whereas violence against women is a Canadian public health crisis that demands urgent action; and

Whereas one in four women experience domestic violence in their lifetime. One woman or girl is killed every other day, on average, somewhere in our country; and

Whereas the most dangerous time for a victim of abuse is when she separates from her partner. According to research from the U.S. Centre for Disease Control and Prevention, when there is a history of coercive control, violence and a recent separation, a woman's risk of domestic homicide goes up 900 times; and

Whereas the current Canadian court system is not equipped to protect women. According to the National Judicial Institute, there is no mandatory education for Judges on domestic violence. Judges need education on what constitutes domestic violence or coercive control. A formal education program would ensure

another line of defense for victims, as well as preventing violence and abuse before it happens; and

Whereas the COVID-19 pandemic has only exacerbated the domestic violence crisis. Women's shelters and crisis centres have reported a marked increase in requests for services this year. The concerns for children are significant.

According to recent research from The Children's Hospital of Eastern Ontario, doctors have seen more than double the number of babies with serious injuries as this time last year. These include head injuries, broken bones or in some cases death. Institutions across the country are reporting a similar trend; and

Whereas, according to Article 19 of the UN Convention on the Rights of the Child, children must be protected from "all forms of physical or mental violence, injury or abuse, neglect or negligent treatment, maltreatment or exploitation, including sexual abuse, while in the care of parent(s), legal guardian(s) or any other person who has care of the child." Our current family justice system often fails our children in this regard; and

Whereas, in worst case scenarios, children are killed by a violent parent. As reported by the Canadian Domestic Homicide Prevention Initiative, recent separation and domestic violence are the two biggest risk factors for domestic violence related child homicides; and

Whereas custody disputes are an additional risk factor. Each year in Canada, about 30 children are killed by a parent. Mothers are responsible about 40 per cent of the time, often due to postpartum depression or mental illness. In the 60 per cent of cases where fathers are the murderers, anger, jealousy or post-separation retaliatory revenge are the usual motivations; and

Whereas Keira's Law is named after four-year-old Keira Kagan, who was killed while in the custody of her father, in 2020; and

Whereas many cases of domestic violence are inappropriately labelled as "high conflict" in the family court system. According to research by Rachel Birnbaum, a Social Work Professor at the University of Western Ontario who specializes in child custody, approximately one third of cases called "high conflict" by the court had substantiated evidence of valid concerns about domestic violence. These cases must be recognized and treated differently by judges; and

Whereas voting in favour of "Keira's Law", contained in Private Member's Bill C-233, will not only protect victims of violence and children, it will save lives by

amending the *Judges Act* to establish seminars for judges on intimate partner violence and coercive control;

- 1. Now Therefore Be It Hereby Resolved That Aurora Town Council calls upon the House of Commons to support Member of Parliament Anju Dhillon's Private Member's Bill C-233, that will raise the level of education on domestic violence and coercive control for federally appointed Judges; and**
- 2. Be It Further Resolved That a copy of this resolution be sent to: The Right Honourable Justin Trudeau, Prime Minister of Canada; The Honourable Karina Gould, MP, Minister of Families, Children and Social Development; The Honourable Candice Bergen, Interim Leader of the Conservative Party of Canada; Yves-Francois Blanchet, MP, Leader of the Bloc Quebecois; Jagmeet Singh, MP, Leader of the New Democratic Party; MP Tony Van Bynen; and MP Leah Taylor Roy; and**
- 3. Be It Further Resolved That a copy of this resolution be circulated to all Ontario municipalities and the Federation of Canadian Municipalities (FCM).**
